It is a Kennel Club regulation for judges to write and submit a critique for publication in the weekly UK dog press.

*Judges appearing on the A3, B and C list were added prior to The Kennel Club adding new requirements for judges not yet passed to award CCs in a given breed. Our support for the Judges on these lists remains the same, however we recommend that show societies inviting Judges listed on the A3, B & C lists, check directly with the Judges that they meet all Kennel Club requirements appropriate for the appointment.
